

Trip Application

I, _____, acknowledge that I have voluntarily applied to participate in the trip _____.

I am voluntarily participating on the tour or expedition with knowledge that travel to the countries and/or remote areas visited by this trip involves numerous risks and dangers including, but not limited to: the forces of nature; civil unrest; terrorism; roads, trails, hotels, vehicles, boats, airplanes or other means of conveyance which are not operated or maintained at standards common in the United States; high altitude; accident or illness without access to means of rapid evacuation or availability of medical supplies; the adequacy of medical attention once provided; physical exertion for which I am not prepared; consumption of alcoholic beverages; or nonwillful negligence on the part of Num Bum Adventures or others. I acknowledge that the enjoyment and excitement of adventure travel is derived in part from the inherent risks incurred by travel and activity beyond the accepted safety of life at home or work and that these inherent risks contribute to such enjoyment and excitement, being a reason for my voluntary participation. I acknowledge that the cost of all Num Bum Adventures trips is based upon trip participation executing this Release of Liability and Assumption of All Risks. Therefore, as lawful consideration for being permitted to participate on such trips, I hereby release and discharge Num Bum Adventures and its agents and employees from and against any and all liability arising from my participation in the adventure trip. I agree that this release shall be legally binding upon myself, all minors under the age of 21 traveling with me, my heirs, successors, assigns, and legal representatives; it being my intention to fully assume all the risk of travel and to release Num Bum Adventures from any and all liabilities to the maximum extent permitted by law. I understand that all applications are subject to acceptance by Num Bum Adventures and upon acceptance shall be deemed to have been entered into and to be performed in Stevensville, Montana, U.S.A. In the unlikely event a legal dispute should arise involving any subject matter whatsoever, I agree that the maximum amount of recovery to which I will be entitled under any and all circumstances will be the land cost of my trip with Num Bum Adventures. I have carefully read and fully understand the contents and legal ramifications of this agreement as well as all the conditions for the trip I am applying for. At time of application I understand that I may not cancel my trip thirty (30) days from the first established day of the trip. For the trip _____ that day is _____.

If I cancel my trip during this time period for any reason I forfeit all deposits* and payments and will not be entitled to a refund. I hereby agree to be responsible for my own welfare, and accept any and all risks of delay, unanticipated events, illness, injury, emotional trauma, or death. Further I acknowledge it is my responsibility to provide personal trip cancellation

insurance, flight insurance, health insurance including the cost of remote rescues or removal, luggage insurance and am responsible for my own personal effects. I understand this is a legally binding and enforceable contract and sign it of my own free will.
